AIR PIPING REPLACEMENT

Englewood Water District (EWD) is requesting sealed bids to secure the services of an experienced, professional, licensed, and qualified contractor capable of providing services in accordance with the specifications for the replacement of Englewood Water District Wastewater Treatment Plant Number 4's steel air piping and a segment of steel air piping for Plants Number 1 & 2. The existing air piping is constructed of 14-inch carbon steel which is buried below grade. The existing piping is failing in multiple spots and requires a full replacement. The contractor is to remove approximately 500 linear feet of existing 14-inch steel air piping and install new 16-inch coated steel air piping with cathodic protection test stations. The plant is currently in service and shutdowns will be required and need to be coordinated.
